BOND & FEE NOTIFICATION FORM

Congratulations! You may now be eligible for a contractor's license. Please submit all items / documents listed below to the Contractors State License Board (CSLB) along with this letter. These items / documents will be processed in the date order received. These items / documents must be received by 07/11/2021 or the application will be void and you will have to reapply.

- This application requires that you submit a <u>new</u> original Contractors Bond form 13B-1 or Cashier's Check in the amount of \$15,000 in the current business name of this application. <u>Bonds are not transferrable from one license to another.</u> Bonds must be typed by a surety, and the business name must match the name printed above.
- You must submit a Certificate of Workers Compensation Insurance or a Certification of Self-Insurance of Workers' Compensation from the Director of Industrial Relations. Contractors State License Board must be shown as the certificate holder. If you do not have any employees subject to the workers' compensation laws of California, you must submit an ORIGINAL Exemption from Workers' Compensation form 13L-50. The Exemption from Workers' Compensation form can be submitted online at: https://www.cslb.ca.gov/OnlineServices/WebApplication/InteractivePDFs/WorkersCompensationExemption.aspx.
- All applicants are required by law to submit a full set of fingerprints for a criminal background check. The Request for Live Scan Service form package you received must be taken to a Live Scan site for fingerprinting. Live Scan services are available at most local police departments, sheriff's offices, the Department of Justice, or any public applicant Live Scan site. Failure to meet this requirement can result in your application being voided. If you do not have the Request for Live Scan Service form, contact the Contractors State License Board for a duplicate.

Information on Alternatives in Lieu of Bond Requirements

IMPORTANT: A cashier's check or bank-certified check must remain on file with the Contractors State License Board for a holding period of three years <u>after</u> the expiration of the license period for which the cashier's check or bank-certified check was given. This will result in a holding period of more than three years.

NOTE: If the board is notified of a complaint relative to a claim against the cashier's check or bank-certified check, the deposit shall not be released until the complaint has been adjudicated.

A cashier's check or bank-certified check is held because a claim may be brought against a cashier's check or bank-certified check within three years after the expiration of the license period for which the cashier's check or bank-certified check has been provided, or within three years of the date the license was inactivated, canceled or revoked by the Board, whichever occurs first.
